**ELIGIBILITY**

Applicant must be a graduating senior with an academic standing in the top 25% of his/her class, attending one of the following high schools of Lebanon County: Annville Cleona High School, Cornwall Lebanon School District, Eastern Lebanon County School District, Lebanon Catholic Jr./Sr. High School, Lebanon School District, Northern Lebanon School District, and Palmyra Area School District.

Applicant must be a good citizen and of good moral character.

Applicant shall have applied to and/or have been accepted by a 4-year accredited college or institution, including the Lebanon Campus of Harrisburg Area Community College, in a program leading to a Bachelor's degree, or its equivalent.

The completed Application, together with the essay, must be submitted to the Guidance Department of Applicant's high school no later than \_\_\_\_\_, 2019\*\*\*. **ONE applicant shall be selected from each school by the school's judging committee. A representative of the school's judging committee shall submit its school's applicant's Application and essay no later than March 29, 2019, to: LESLIE A. The essay shall be limited to a maximum of 750 words and shall be written on a topic chosen by Buzgon Davis Law Offices, said topic to be submitted on an annual basis prior to January 15<sup>th</sup> of each scholarship year to the Guidance Department of each participating Lebanon County high school.

**JUDGING SHALL BE BY A COMMITTEE SELECTED BY EACH PARTICIPATING HIGH SCHOOL WHICH WILL DETERMINE ONE APPLICANT FROM THAT SCHOOL BASED ON THE FOLLOWING CRITERIA:**

Essay	75%
Class Standing	20%
SAT Score	5%.

The Application and essay of ONE applicant shall then be submitted to the Scholarship Committee of BUZGON DAVIS LAW OFFICES as aforementioned. The BUZGON DAVIS LAW OFFICES SCHOLARSHIP COMMITTEE will review and evaluate the essays to determine three finalists. The BUZGON DAVIS LAW OFFICES SCHOLARSHIP COMMITTEE will personally interview each of the three finalists and shall then determine the recipient of the 2019 Buzgon Davis Law Offices Scholarship based on the following criteria:

Essay	50%
Personal Interview	50%.

Each of the three finalists will be personally interviewed by the BUZGON DAVIS LAW OFFICES SCHOLARSHIP COMMITTEE at 525 South Eighth Street, Lebanon PA.

The BUZGON DAVIS LAW OFFICES SCHOLARSHIP COMMITTEE will, in its sole and exclusive discretion, choose the recipient of the 2019 Scholarship Award.

**SCHOLARSHIP AWARD PAYMENTS TO RECIPIENT**

The amount of the Scholarship grant shall be \$3,000, distributed over a 4-year period, payable at the rate of \$750 each year directly to the recipient upon submission of proof, satisfactory to the donor, that the recipient is enrolled for the ensuing year at a specified accredited college.

The amount of the Scholarship Award given to any student is a grant, i.e. a gift, and is not a loan.
